Ferry Birds – Sept 2020 to Jan 2021

My bird watching has been somewhat curtailed recently, but the usual waders and gulls have been seen regularly in West Bay. The redshank are the star attraction. There are about 50 using the floating mooring at high tide when they can no longer feed on the mud. They are joined by 1 or 2 curlew, a few turnstone and dunlin and the occasional oystercatcher. The latter prefer searching the seaweed rocks near Pierhead covered buildings so are not constrained as much by the state of the tide. .A rock pipit can often be heard feeding in the same place.

around West Bay have included a few cormorants, a pair of mallard and 3 shelducks in the middle of January. Other sea birds have been a bit scarce but now is the time to spot the fulmars on Inchgarvie making flying visits to check up the Inch is still there! I forgot to mention last time the blackheaded gulls which took over West Bay in late spring and June. I reckoned there were often up to 100 scattered around the bay. I don't remember seeing anywhere near this number in the bay before. There are a few still around but a handful at the most.

Other birds I have been told about have included a male blackcap and a treecreeper in a garden overlooking West Bay. The latter are a resident species but blackcaps used to be very uncommon

in winter as they prefer warmer climes and consequently flew to Africa for the winter. A consequence of global warming perhaps!

The resident commoner birds have been noted around the village with house sparrows seen and heard near the station and in the beech hedge at Carlingnose. There have also been a few starlings on the school and also at Pierhead buildings. I heard a mistle thrush near the station in December and a song thrush at the bottom of The Brae at the beginning of the year and there are also plenty of blackbirds, crows and magpies around.

2020....time Whatever happened to seems to be vanishing for many people and your community councillors are no exception. The actions and decisions of one Community Council meeting seem to blend into the next, or is it that some village issues are difficult to solve and are so long standing, such as the antisocial behaviour in the lower part of the village and the fate of the Albert which we all sorely miss? There are, however, always new and more positive issues to consider such as developing cycling activities around the village (please see separate article) and the good news is that a solution to another issue which has plagued the village for some years is in sight. Fife Council is actively considering a public toilet for the village in the Battery Road car park. Finance is set aside and it is now just a matter of settling on a design suitable for a position so near the World Heritage Forth Bridge.

Possibly because of the pandemic, this year saw your councillors actively promoting the festive season by initiating, supporting and acting on several festive projects in addition to supplying the Christmas tree which was displayed beside the War Memorial. Local children enjoyed a virtual party, local residents helped light up the village by taking part in a campaign 'North Queensferry: Vilactively sought funds and worked with when contacted by the public. 'Shield' (a local food distribution network) to support local people in difficulties due to the pandemic. It is worth noting that Shield intends to continue its activities in the village – please see separate article.

Your Community Council continues to hold its monthly meetings albeit on Zoom and we continue to look at and try to solve community concerns. A benefit of these Zoom meetings is that many more village residents link in to the meetings, express their views and highlight specific issues. An example of this is the public concern expressed over what appears to be Network Rail's cavalier attitude to communication with residents particularly about working hours, noise and safety. The Community Council is in communication with Network Rail and are working with Fife Council and local Members of Parliament to solve these issues.

Cycling around North Queensferry

Last summer saw a multitude of people out and about North Queensferry enjoying the beautiful village we are so lucky to live in. North Queensferry is exceptionally well placed for the National Cycle Network with routes around the Forth, into Edinburgh, to St Andrews, Perth and beyond. Currently we are seeing many more walkers, runners and cyclists sharing the routes around the village.

Fife Council consider that North Queensferry would benefit from the development of a Local Action Plan which would highlight the short, medium and long-term priorities of the village. As we head into 2021, this is an ideal time to get any ideas you may have into a coordinated action plan.

There are many opportunities for improving cycling routes around the village and making them safer for walkers and cyclist to enjoy together. Adding a cycle 'slipway' on both lots of steps by the Road Bridge would link the lower and upper parts of the village. Reducing the speed limit on Ferryhills Road and the road (B981) out of the village, past the hotel (DoubleTree by Hilton) would make it safer for all. Asking the Fife Coast and Countryside Trust to cut back and widen the Coastal Path would make sharing the paths easier and safer. The Community Centre could benefit from dedicated cycling racks for the users of the Centre and the MUGA. Further afield there have been proposals suggesting turning the railway from Inverkeithing to Rosyth into a walking/cycle path.

Hopefully village residents will come up with many more ideas ,and not just limited to cycling either! Consultation for the Local Action Plan is launching soon so please contribute where you can. Until the more formal routes into the plan are set up the Community Council will coordinate and consolidate any responses. Please email:

North Queensferry Local Action Plan (NQLAP)

Fife Council's South and West Fife Community Development Team are working in partnership with various Fife Council and partner agencies to develop and deliver an area wide consultation to assist the development of a NQLAP.

Timescales for the consultation will be from late January, through to July 2021, where we have been tasked with having a draft plan ready.

While in the middle of a global pandemic we aim to utilise the use of online and social media platforms to engage with local people. We hope to engage directly with resident's face to face where all social distancing guidance will be followed.

Most community groups and voluntary organisations have been contacted by letter to make them aware of the NQLAP Consultation and asked to pass on to their wider networks.

The NQLAP will focus on raising the profile of North Queensferry, in particular the World Heritage UNESCO site; the fantastic Forth and Queensferry Crossing Bridges, raising awareness of the tourism opportunities, develop the local economy and to ask local groups and residents what they would like to see improved or established in the North Queensferry Area.

Officers from Fife Council and partner agencies will work directly with local community groups and individuals to gather

all **your** thoughts and ideas on what the NQLAP should contain.

The NQLAP will be a fluid document that contains short, medium- and long-term outcomes. Officers are very keen to hear about what the North Queensferry community would like to see or do in their neighbourhood. What community initiatives would **you** like to see in the development of the NQLAP.

The article in the Local Ferry News is one of a number of communication strategies to assist contacting local groups, schools, churches and most importantly local residents who wish to participate in the NQLAP Consultation.

Creative containers

North Queensferry Maker-Space? A Repair Shop for the village? A place to get on with some sewing with a friend? Workbench space for your wood work project? North Queensferry Community Trust has planning permission to place five shipping containers in the old Balfour Beatty car park, in the fenced off area to the north of the old Railway Pier, towards the defunct railway tunnel. The plan is to use three of them to create community workshop spaces and tool libraries for anyone needing somewhere for their activities and crafts such as metalwork, electronics, sewing, yarn crafts, glass making the list is endless. A fourth container is intended for storage of tools, equipment and individuals' or groups' works-inprogress while the fifth will be used by the Lothian Sea Kayak club to store kayaks. The Trust has also placed two donated boats in this area of land: both could be made sea-worthy and then either used as community owned boats for sailing or sold to fund new Trust projects.

Ideas and details for this project are in the process of being worked out. There is still some flexibility so if you have an idea that would work in these spaces please get in touch. Plans are at a very early stage of development, meanwhile the Trust is putting together a budget to start looking at funding opportunities and to decide, for instance, whether the fitting out of the containers with windows. doors, power, insulation and cladding will be carried out by volunteers, contractors or a mixture of both. Besides individual use, these containers could be valuable spaces for drop-in sessions to learn and share skills or perhaps to use as bookable venues for a weekend activities including taught courses.
